

ORDINANCE NO. 689

AN ORDINANCE AMENDING THE 2017 BUDGET OF THE TOWN OF ODESSA  
AS ADOPTED BY ORDINANCE NO. 678

WHEREAS, the Town of Odessa adopted the 2017 budget in final form by Ordinance No. 678 the 12<sup>h</sup> day of December 2016; and

WHEREAS, subsequent thereto it has become necessary for the Town to amend said Ordinance because of revenues and expenditures of same, which could not reasonably have been foreseen at the time of adopting said budget; and

WHEREAS, said expenditures are not one of the emergencies specially enumerated in RCW 35.33.081; and

WHEREAS, the Town is desirous of amending its budget pursuant to RCW 35.33.091; and

WHEREAS, the Town introduced said budget amendment on the 11<sup>th</sup> day of December 2017,

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE TOWN OF ODESSA, WASHINGTON:

Section 1. The following accounts contained in the 2016 budget are hereby amended as set forth below:
